TERMS & CONDITIONS

As far as I (the parent/carer) am aware, I have disclosed to my swimming teacher all information regarding my health and my child's health relevant to the practice of Baby Swimming. I take full responsibility for the health of my baby & me in the swim sessions & will consult my swim teacher if there is a change in medical status.

If there is a known medical condition for the adult or child swimmer please consult a professional medical practitioner before coming swimming. Always check with a medical/health practitioner if you require further information on an illness or condition as Little Turtle Swim Company are not qualified to offer advice in this department

Do not take your child swimming if they have an infectious condition - including diarrhoea, sickness & a heavy cold ~ it is important to wait two days after the first solid movement before going swimming if your baby has suffered from an upset tummy

After swimming ensure you take special care with drying your baby, especially their ears ~ Babies with ear infections should not swim

Please let your teacher know if there is any change in the status of medical condition for your child; whether it is a previously disclosed or new illness

I (the parent/carer) take full responsibility for all applications of Baby Swimming I may practise outside Little Turtle Swim Company classes both now and in the future. I accept that Little Turtle Swim Company does not take responsibility for any applications of Baby Swimming practices described or shown in books and DVD's.

I (the parent/carer) understand Little Turtle Swim Company will not be liable for any loss, damage or injury whilst on pool premises.

I (the parent/carer) fully understand that the recommendations, ideas and techniques expressed and described during Little Turtle Swim Company classes, as well as in books and DVD's endorsed by Little Turtle Swim Company cannot be regarded as a substitute for the advice of qualified medical practitioners. Any uses to which the recommendations, ideas and techniques are put are at my sole discretion and risk.

I (the parent/carer) accept my baby must wear double layer of protection in the pool; an inner layer & an outer nappy/snug wetsuit that creates a seal around the leg & waist - in the event my child soils the pool I may be liable for the associated costs. Without the double nappy layer my child may be refused entry into the Little Turtle Swim Company session.

Photography is not permitted at the Novotel Hotel, Milton Keynes or at the Gateway School, Tiffield. Underwater photographs may be available via Little Turtle if your child has completed a number of, & is comfortable with submersion ~ the specific criteria can be discussed with Little Turtle if you would like a photograph. Consent will always be sought before any photographs are taken.

All lesson times and venues are subject to change, however all participants will receive prior notice & where alternative lessons are offered no refunds will be given. Little Turtle Swim Company will not be at liberty to refund money or defer your class, in the event of your inability to attend some or all of the lessons.

Should you cancel at any time prior to the week before the course begins we will refund you your money. Should you cancel in the week prior to your course commencing we will issue a refund minus £20 administration charge. We regret that once the course has commenced, regardless of circumstances, we cannot issue refunds or credits.

Be careful moving around the pool as surfaces can be slippery. Do not enter the water until you are told to do so. **Never leave your child unattended at any time**
